Cabrillo Middle School:

Add (3) portables for temporary housing - Summer 2017 Campus Fire Alarm upgrade copper to fiber - Bidding Programming new 2-story P.E. / Classroom Building

Peterson Middle School:

Structural Issues with Auxilliary & Exercise Gyms, repair is under review with DSA (Division of State Architect), Occupancy for

Main Gym will be March 7, 2017 with the other buildings to follow on April 7.

Locker Building Modernization - building replacement is under consideration instead of modernization. The building is sized for high school use, it is a non-ductile concrete shell, and possible structural

issues. New Pool house and replacing the existing two pools with one.

Fields - Reconstruction part of Patrick Henry / DRC project master plan.

Interactive Projector Projects

Summer 2017 - Remaining classrooms at twelve school campuses including Montague and Hughes will receive interactive projectors and sound system.

Central Park Elementary School:

Multipurpose Building and New Kitchen will be complete in early May 2017.

New Administration Building is out to Bid, with completion in the early Fall 2017.

2-story Building project is in programming, a CEQA will be required, completion Summer 2018.

Mayne Elementary School:

Modernization and New Parking Lots with Site Renovation and landscaping schedule for May thru September 2017.

Agnews Site:

RFO for Architects, down to three LPA - Southern California, HMC, and OKA Quatrocci Marin. Rankings will be done, along with proposal requests, schedule and fee are due and by end of January a contract

will be issued to first ranked firm.

Water Tower - DSA is reviewing design criteria developed by structural engineer, once accepted and drawings completed, estimate will be done. To remove the Tower the cost must exceed \$1.5M plus the

to demolish the tower. Sprint is leasing the Tower for the past two years, their renewal is every six months.

Salvage - Historical salvage has taken place in Building 151, tiles, weather vanes, grills, terra cotta tile. Scope has been developed based on this initial work, the other buildings will be out to bid soon.

- Full Circle Farms District is not interested in selling land, their area of use may shrink once the site is configured for possible new elementary and District Resource Center.
- Monticello- New Valley High School move and redesign to accommodate future elementary school and county programs. Jim van Pernis asked are we receiving county funds for the program. Mark Allgire responded that these are District students and we are obligated to help house and facilitate their program.

#### CIOC.MH14.004- Financial Update 005

Measure H 2014 - The Bond Project Office is using a cost breakdown that the Board and the Facilities Needs Task Force has reviewed for budgeting purposes. Projects are grouped utilizing the voter-approved Bond Projects list categories.

Revenue to date from the \$419,000,000 Bond Authorization is \$141,145,188. (Authorization remaining to be issued is \$278,400,000). Expenditures to 12/5/2016 are \$53,010,534.
